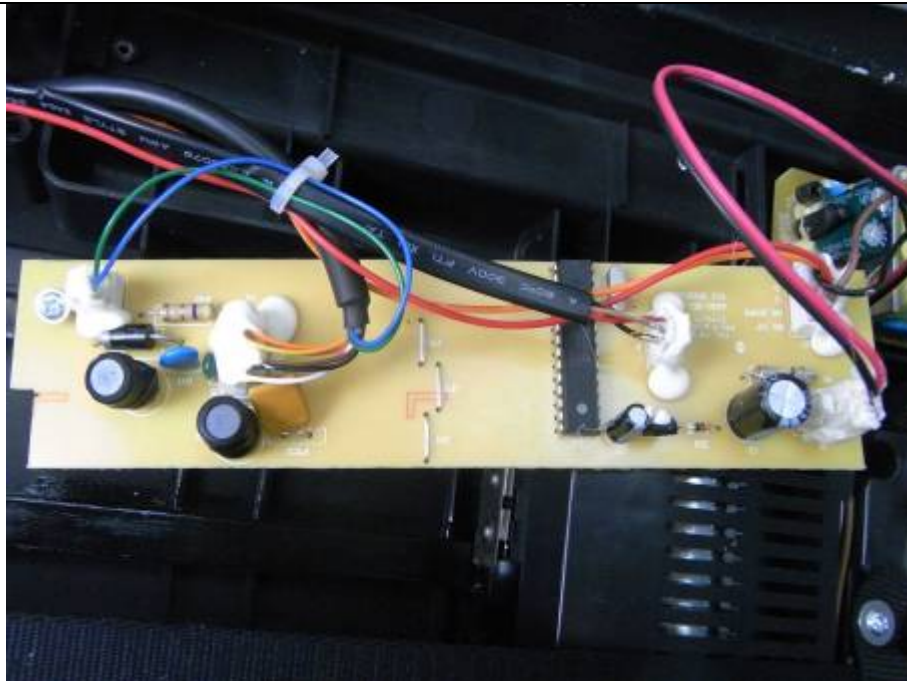

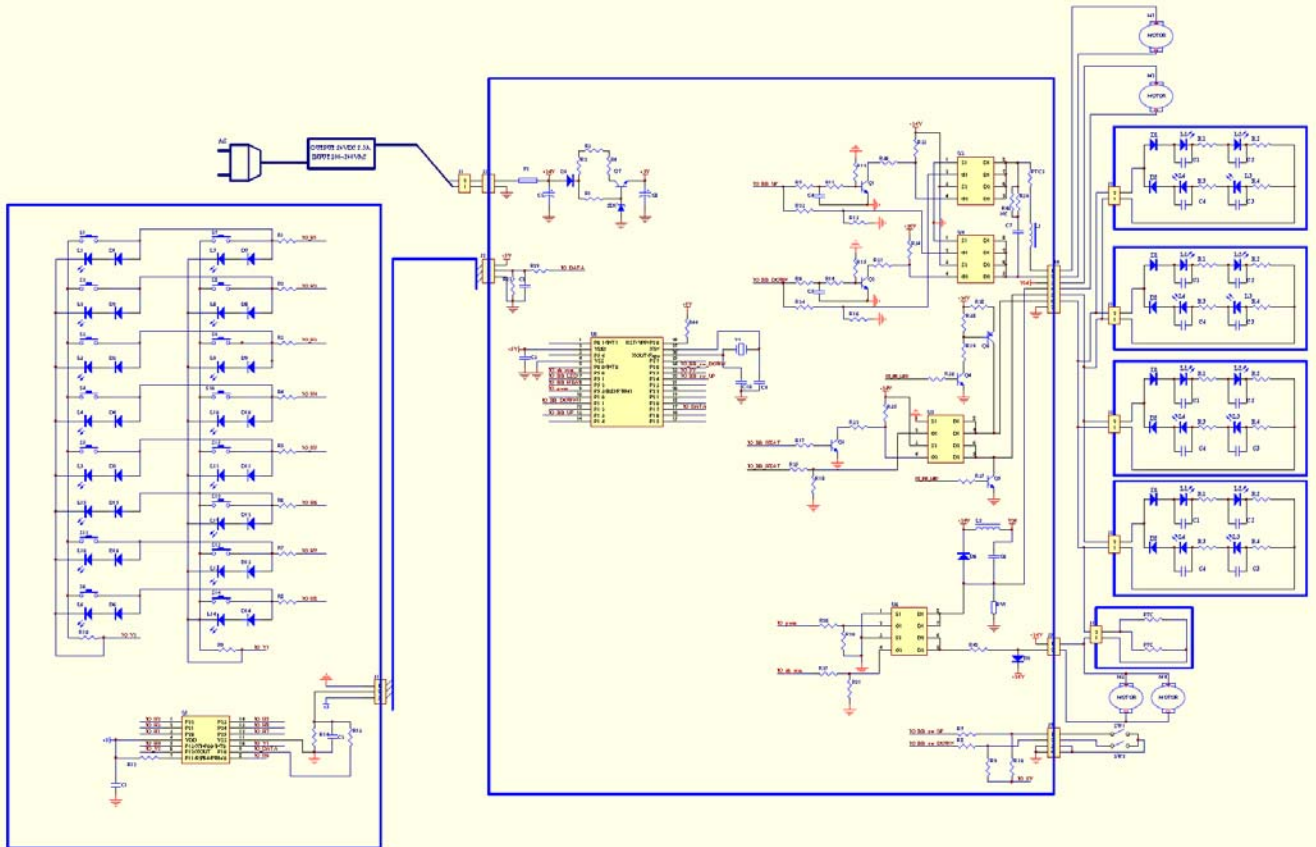

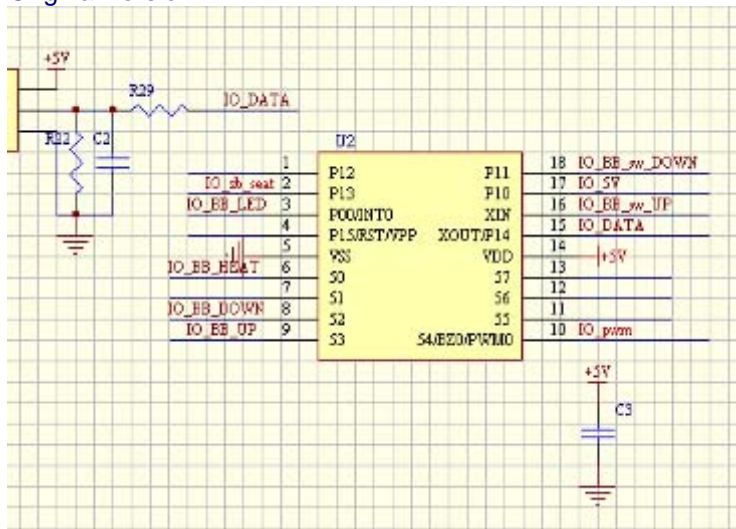
Circuit diagram documentation

New main circuit diagram

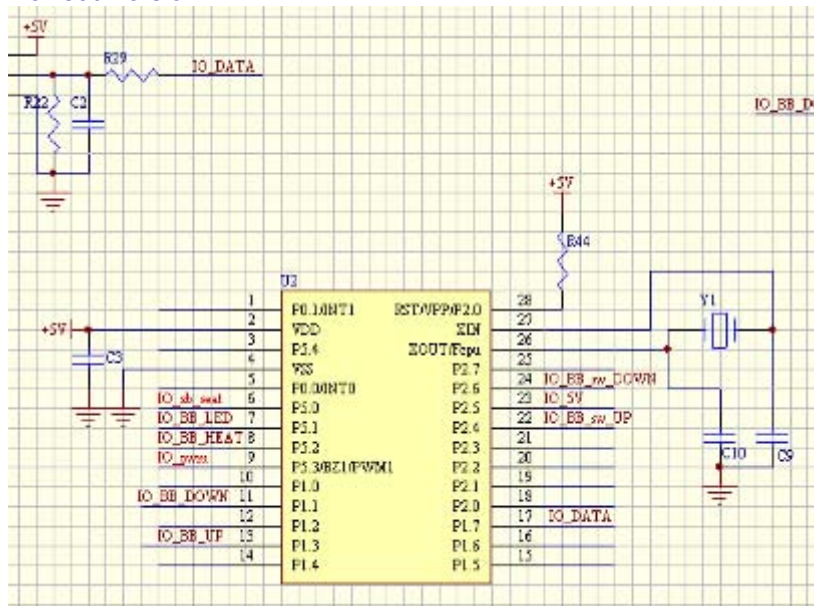
